Lieutenant W.C. Abbott Meade, son of Mr. W.C. Joyce Meade, has had adventures which support the contention that fact is indeed stranger than fiction. The experiences related by him in a letter he has sent home exceed in interest many which have been imagined by authors of books of adventure, and he was having these experiences after he was "officially dead". The Admiralty reported that he was drowned in the Indian Ocean on April 21st last, but, though he and a companion had to display much courage and much resource in order to avoid a watery death, they are happily both alive to tell the tale. Lieut. Meade's telling of it gains in impressiveness rather than otherwise by his indulging in no ornate description of what befell him and his comrade, but narrating the facts with simplicity of language. The letter, addressed to his parents, is dated April 27th, and in it he says:-

"I daresay you have heard that I was missing for a few days in April. Here is a short account of my doings. I am writing this letter at Male Island, the head island of the Maldivé Group, where we arrived this morning in a native dhow. On the 21st we left the ship to do a flight, and had to come down on account of darkness. As soon as we had come down we got on to a coral reef and had to get out of the machine and move the coral to get it off. ~~This~~ we were unable to do, but fortunately the tide drifted us off. We then rigged up a W.T. station on the machine, but the spark was not strong enough to send a message very far, and our messages never reached the ship. My hands were frightfully cut about with the copper aerial wire. We then had to try to get to an island for the night, and owing to the coral reefs we had the greatest difficulty in getting through the channel. We used practically all the lights we had before we arranged to get her beached on an uninhabited island. The machine was damaged, and we tied it up for the night. Rain fell continuously for the next twelve hours, and we had no clothes and food. We were wet through and weak after the exertions of the previous night. We could not stay on an uninhabited island. We had a little petrol left, so covered the magneto and plugs with my coat and hoped to make a start on the sea towards another island when the sun came out. This it did at three o'clock, and we tried to get her off. She failed to start at first, but after changing the plugs she - thanks be! - started. I had been walking about all day with no clothes whatever, as my shirt and trousers were wet through and drying in the wind. We now got to the outer channel, and the machine again got on the coral. We got out to push her off, but the engine would not move, there being no air left in the bottles. We then got behind the floats and tried to swim behind them to

get the machine to shore. We were not strong enough for this. So after deciding that the one thing to do to save ourselves was to swim for the shore, two miles away, we had a rest and cut out the balloon from the machine. The pilot took a Gieves belt and I took the balloon. We never thought we would get to shore that distance, through a shark area, too but it was the only hope. Eventually after about an hour we got there, rather tired, and settled down for the night. There was no food available. At midnight we heard the sound of voices, but when we greeted the owners with the word "Salaam" they bolted. The next morning we went to look for them, and on our return they had gone with the only boat in the island. We then ransacked a hut, but only found a few cocoanuts and about 12 chickens. We at once killed one and made a fire to cook it. I helped kill and pluck it. At mid-day we sighted a dhow, and we took a pole and waved my trousers on them. After shouting for about an hour we managed to attract their attention. They came close in and we swam out and got aboard. All these natives were so scared of us. The seaplane had, contrary to our expectations survived the night and had drifted three miles out to sea. We then towed it in to Fialands. Here we were entertained by the natives for two days, and then we were taken in a dhow to Male Island. No one on the island could speak English and it was very difficult to get them to understand what we wanted. If you wanted food you had to point to your mouth. We had a great deal of difficulty in getting them to understand that we wanted to go to Male and Colombo. We slept in this island in a hut made of cocoanut matting and wood, and for pillow and bed had cocoanut matting also. We slept in this place with about 50 men, and they would insist on our singing through a great part of the night. Our food was rice and cocoanut, and smoked fish all the time; always eating with our fingers. The native women were kept well away from us. They wore thin blue frocks and hats. They were fairly handsome, but very filthy in their habits. They displayed the greatest interest in the seaplane. We spent 36 hours on the dhow, with only rice to eat and boards to sleep on and were brought here, where the Sultan of Maldives is looking after us. We are being well looked after"

Lieut. Meade concluded his letter by saying he had just heard they were to set sail for Colombo, which was about three days' journey.
